### SECTION I. INTRODUCTION

**DevAcrobats Ltd** (formerly Nara Syst Ltd.) is a software company established in 2005 and specialized in front-end JavaScript development and Atlassian apps development.

**Performance Objectives: Charts & Reports for Jira Dashboards app** is a powerful tool for KPI, SLA and OKR reporting; objective recognition of personal and team goals; chart and pivot time tracking, developed by DevAcrobats Ltd. The app is compatible with Jira Service Management and Jira Software.

This Cookie and Privacy Policy applies where DevAcrobats Ltd. processes personal data and acts as a data controller. In this Policy 'us', 'we' and 'our' refer to DevAcrobats Ltd.

## **SECTION II. PERFORMANCE OBJECTIVES: CHARTS & REPORTS FOR JIRA DASHBOARDS app**

This section applies to customers and users of *Performance Objectives: Charts & Reports for Jira Dashboards* app.

### **II.1 What types of data we collect:**

1. We collect usage statistics for the app (for both downloadable and Cloud versions). **No Jira instances data and no personal data is collected through these usage statistics.**
2. When you install for a free trial or purchase *Performance Objectives: Charts & Reports for Jira Dashboards* app (for Cloud, Server or Data Center), we get access to your personal data associated with your Atlassian product license, such as: name, e-mail address, technical and billing contacts, license type and status, ID (SEN), hosting type and sale channel.
3. We may receive your personal data (for example your e-mail and name) when you raise a ticket in our Service Management System.
4. We may receive your personal data if you write an e-mail directly to us.

5. When you use the Cloud version of *Performance Objectives: Charts & Reports for Jira Dashboards* app, the Cloud app servers generate log files to help us operate. The log files include internet protocol, IP addresses, browser type, operating system and the app URLs accessed during the app usage.
6. After you have contacted us for support, we may ask you to send us some additional information during our support service, for example screenshots with the app configuration. We use this data only for the purpose of providing high quality support to our customers and not for any other purposes.
7. Please note that we do not collect and process any sensitive personal data which may reveal racial or ethnic origin, financial position, political, religious or philosophical beliefs, membership in trade unions or other organizations, clubs, etc., genetic and biometric data, health status, sex life, sexual orientation, debit or credit card details of our users.

Sensitive personal data might be exposed to us only in cases when you (or your organization or employer) send it to us (intentionally or accidentally) by email or by raising a ticket in the Service Management System of DevAcrobats Ltd., though our Customer Support does not require receiving any of it.

## **II.2 Legal bases and purposes of collecting personal data:**

By installing for a free trial or purchasing our app *Performance Objectives: Charts & Reports for Jira Dashboards*, you accept this Policy and enter into a contractual agreement with us through Atlassian Pty (we act as a third-party vendor for Atlassian), which gives us legal bases to process your personal data.

The legal bases for processing your personal data are:

- our legitimate interests, namely the proper administration of our business, including monitoring and improving our websites, services and products; the protection and assertion of our legal rights, your legal rights and the legal rights of others.

- when such processing is necessary for compliance with a legal obligation to which we are subject, or in order to protect your vital interests or the vital interests of another natural person.
- your consent.

Purposes of collecting information: to communicate with you, to provide you with support, to receive feedback.

### **II.4 How we store and secure data:**

Overview

DevAcrobats Ltd. is committed to protecting the personal data of its customers and users. We work hard to maintain physical, electronic and procedural safeguards to protect your information in accordance with applicable data protection requirements. However, we draw special attention to the fact that there are risks in the provision of personal

information, whether this information is provided in person, by telephone, online or other media or terminal. So far, there is no system or technology that is completely safe and protected from "hackers". We have made every effort and have provided appropriate measures to prevent and minimize the risks of unauthorized access, misuse and inaccuracy of personal information.

#### **II.4.1 How we store personal data:**

Heroku Cloud Platform (<https://heroku.com/>) used as PaaS (Platform As a Service).

Google Drive account, owned by DevAcrobats Ltd.

#### **II.4.2 How we secure data:**

##### **People and Access**

DevAcrobats Ltd. team accesses Heroku data only for purposes of application health monitoring, system and application maintenance and troubleshooting and only authorized DevAcrobats employees have access to it.

##### **Vulnerability Management**

DevAcrobats has established process to review any reported vulnerabilities and act on them. Security team attempt to release hotfix within 4 weeks of critical vulnerabilities identification. In addition, Atlassian team gets notified immediately after identification of any vulnerability.

##### **Backups**

DevAcrobats database backups are made on 24h and include only Atlassian Connect application registration information. All backup data is stored in Heroku and Google Drive.

##### **Disaster Recovery**

DevAcrobats team has integrated system of constant monitoring that proactively identifies outages. In addition any issues with the app can be reported under [Support System](https://narasyst.atlassian.net/servicedesk/customer/portal/1) (<https://narasyst.atlassian.net/servicedesk/customer/portal/1>) that will notify immediately our support team. Operations team attempts to restore system back to normal within time frames defined under [Service Level Agreement \(SLA\)](https://performance-objectives.com/service-level-agreement-sla/) (<https://performance-objectives.com/service-level-agreement-sla/>) by restoring data backups or rollback of recent release.

## **Data Recovery**

DevAcrobats stores only license app registration details and on data loss, corruption, DevAcrobats support team can extract and restore from backup history particular registration records within time frames defined under [Service Level Agreement \(SLA\)](https://performance-objectives.com/service-level-agreement-sla/) (<https://performance-objectives.com/service-level-agreement-sla/>).

### **II.4.3 For how long we store personal data:**

DevAcrobats stores your personal data (company name, name and contact details, support requests submissions, etc.) for the whole period of your subscription (trial) plus 2 years after expiration of license/trial, or for a longer period if required by law.

### **II.4.4. Sharing personal data with third parties:**

In our normal activity, we do not share your personal data with third parties.

We may share your personal data with third parties in the following cases:
